EQUALITY POLICY

1. Introduction

- a. Therfield Parish Council is committed to providing and promoting equal opportunities, eliminating discrimination, and encouraging diversity in the community
- b. Therfield Parish Council aims to create a culture that respects and values each other's differences and which promotes dignity, equality and diversity
- c. An up-to-date copy of this policy is to be maintained on the Therfield Parish Council website

2. Purpose

- a. Therfield Parish Council recognises that supporting equality is of primary importance. This policy will help Councillors and employees of the Council to develop sound and effective policies that impact on the local community, whilst ensuring that Therfield Parish Council meets its duties under the Equality Act 2010.

3. Scope

- a. This policy applies to all employees, volunteers, contractors, and Councillors of Therfield Parish Council
- b. All employees and Councillors have a duty to uphold equal opportunities principles. Any breach by them of this policy will be dealt with through the Code of Conduct or the disciplinary process.

4. Equality Act 2010

- a. The Equality Act 2010 applies to public bodies and others carrying out public functions. It supports good decision making by ensuring public bodies consider how different people will be affected by the activities, policies and services required
- b. The Equality Act 2010 places a Public Sector Equality Duty on Therfield Parish Council to work to:
 - i. Eliminate discrimination, harassment, victimisation, and any other conduct prohibited under the Act
 - ii. Advance equality of opportunity between persons who share a protected characteristic and person who don't share it
 - iii. Foster good relations between persons who share a relevant protected characteristic and persons who don't share it
- c. No individual, group or organisation will be discriminated against. This includes, but is not limited to, the following characteristics (known as "Protected Characteristics" under the Act):
 - i. Age
 - ii. Disability
 - iii. Gender
 - iv. Marital status and civil partnerships
 - v. Pregnancy and maternity
 - vi. Race
 - vii. Religion and beliefs
 - viii. Sexual orientation
 - ix. Ethnic origin
 - x. Nationality

5. Equality Commitments

- a. Therfield Parish Council supports the principles and practices of the Equality Act 2010 and recognises that it is the duty of all Councillors and employees to accept their personal responsibility for fostering a fully integrated community at work by respecting and adhering to the principles of equality for all
- b. Therfield Parish Council will actively promote equality throughout the organisation through the application of policies which will ensure that individuals receive treatment that is fair and equitable and consistent with their relevant aptitudes, potential, skills experiences and ability
- c. Therfield Parish Council is committed to:
 - i. Promoting equality of opportunity for all persons
 - ii. Promoting a good and harmonious environment in which all persons are treated with respect and valued
 - iii. Preventing occurrences of unlawful direct discrimination, indirect discrimination, harassment and victimisation
 - iv. Fulfilling its legal obligations under the Equality Act 2010

6. Policy Review

- a. Therfield Parish Council will review this policy as it necessary and appropriate, or at a maximum of three years after adoption
